ENHANCED PDI NEWS !

Most customers who have ordered the new QUICKSTUDY<sup>®</sup> disk should have received it by now. The performance of "PDI, CSI-STOP, and CSI-TREND, according to Joe Maggio, a broker/exchange member, has been excellent. Joey reports 20 out of 20 successful trades in his pre-release use.

Before concluding that PDI will regularly outperform other studies or systems you may have experienced, including the "Greatest Discovery Ever Made About the Markets", you must hear how Maggio has been using PDI. With a background as a floor trader, Maggio doesn't hold positions for the long pull. His trades last one to three days, and he often enters the market at the open or close. Multiple positions are usually taken, and he exits when the market looks soft for further gains.

We wouldn't swap the PDI equation for any "secret", but we will reserve the right to raise the price regularly to protect prior purchasers against market distortion.

Approximately 150 customers received the study disk free by purchasing only \$100 of historical data. As announced in our last News Journal, the historical data purchase requirement went to \$250 as of

July 16th. Next month, we expect to raise the price again, so if you haven't ordered the new QUICKSTUDY disk, we urge you to do so by August 15, when a new price and less generous offer will be in effect. We anticipate eventually selling QUICKSTUDY outright without requiring a historical data purchase. The next price increase may bring this price to \$500 on August 15th.

The additional requirement for historical data had been our way of protecting prior purchasers from compromising the market with these studies. By increasing the required financial commitment the demand will be reduced and fewer users will result.

APPLE PDI READY

Apple users may now also enjoy the PDI Study. Since the Apple version does not hold conventional studies and is limited by speed and capacity, we are offering it for \$195 as an outright purchase.
